- f. Financial assistance to faculty members for research/publications (book, paper), participation in seminars/conferences. Workshops of national/international level organized by renowned institutions of the discipline.

3. EFFECTIVE DATES AND AMENDMENTS

- a) This MOU is signed solely for academic purposes.
- b) This Memorandum of Understanding will come into effect on the date of signature and will remain in force until either side delivers written notification to the other of its intention to terminate the Memorandum. In that case, any Party may terminate this MOU and any related agreement for any reason by giving thirty (30) days prior written notice to the other Party.
- c) The provisions of this MOU may only be amended or waived by mutual agreement by both Parties.
